Adoption and Surrender Animal Humane Society helps thousands of dogs, cats, and critters in need find loving homes each year and no animal is ever turned away. AHS takes in every animal surrendered regardless of its health, age, breed, or behavior. This commitment to open admission guarantees shelter and care to thousands of animals that would otherwise have no safe refuge.

The success of Animal Humane Society's shelter program is reflected in three key measures: the total number of animals admitted for rehoming, the percentage of animals with live placements (placement rate), and the average length of stay in shelter. Although our adoption and

Outreach Animal Humane Society works with individuals and organizations across Minnesota to create a more humane world for animals, including: Outreach to under-engaged communities, including education programs and free or low-cost services that empower low-income pet owners and improve the lives of pets. These programs served more than 9,831 families in Frogtown and East St. Paul. As a result, 933 animals received spay/neuter surgeries and 956 pets were served at free wellness clinics.

Education programs that foster humane values and compassion for animals, including day camps, a youth club, and other activities for kids and families. AHS educational programs served 4,592 people,

Pet Services AHS offers programs to serve all stages of an animal's life, including: Animal Humane Society Veterinary Centers performed 8,748 spay/neuter surgeries and provided 4,476 wellness exams and specialty procedures, all at reduced costs for people in need. Spay/neuter and other non-essential surgeries were prohibited by executive order for six weeks at the onset of the pandemic.

More than 100 family-friendly pet training classes each week, along with one-on-one training and socialization sessions, therapy animal courses, playgroups, and rabbit agility classes. 1,161 pets attended classes through AHS's Training School.

animals, partner with people, and lead responsibly with compassion.

AHS is primarily supported through donations, fees for adoption and
other services, and sales of pet care supplies. We have locations in
Golden Valley, Coon Rapids, Saint Paul, and Woodbury, Minnesota.

Form 990, Part III, Line 3, Changes in Program Services:

In January 2020 AHS discontinued its Animal House pet boarding service
in order to create additional space to support shelter operations and
public veterinary care in its Golden Valley facility.

Later in the year AHS was forced to make significant changes to its
operations and program delivery in response to the COVID-19 pandemic.
In late March AHS closed to the public for six weeks, providing only
limited essential services during Minnesota's stay-at-home order.

AHS continued to provide essential service while closed to the public,
including humane investigations, curbside surrender and stray intake,
curbside veterinary care, Pet Helpline, and care and medical treatment
for animals in our shelters. In May, after the stay-at-home order and
other restrictions were lifted, AHS began reintroducing services with
COVID safety modifications, including adoption by appointment, virtual
education programs, and physically distanced summer camps and pet
training programs. Most of these programs operate on a limited basis or

at reduced capacity due to ongoing COVID safety measures.

The impact of COVID-19 prompted a significant change at the end of the 2020 fiscal year. In June, AHS announced that its 70-year-old St. Paul Shelter location on Beulah Lane would not reopen because the changes required to make that facility safe and functional under COVID-19 were not feasible given the building's remaining useful life.

Form 990, Part III, Line 4a, Program Service Accomplishments:

surrender programs were curtailed by COVID-19, AHS continues to achieve strong results across all three metrics.

In the year ended June 30, 2020:

17,954 companion animals came into AHS facilities.

17,179 of those animals more than 93.4% were placed in homes, reunited with owners, or released to other organizations.

The average length of stay for animals in shelter was 8.9 days.

Placements included 15,021 animals adopted, 1,051 animals reunited with owners, 852 cats returned to field, and 255 animals transferred to partner organizations.

Robust medical and behavioral programs contribute to this continued success:

10,066 animals received spay/neuter surgeries before adoption and 8,748 more were sterilized for pet owners and other rescue groups through our public Veterinary Centers. Spay/neuter and other non-essential surgeries were prohibited by executive order for six

weeks at the onset of the pandemic.

AHS veterinarians diagnosed and treated 18,348 conditions.

AHS Shelter Behavior programs readied 704 cats and dogs for placement.

A Community Cats program focused on reducing euthanasia and providing alternative solutions for feral and free-roaming cats through return-to-field and trap-neuter-return programs. This program served 1,051 cats.

A robust volunteer program that enlists more than 1,800 active volunteers in providing animal enrichment, foster care, shelter support, and other assistance. Volunteers contributed 115,317 hours to AHS and provided foster care for 1,501 animals before adoption.

Aiding animals in critical situations is core to Animal Humane Society's work. Our humane agents respond to reports of possible animal cruelty or neglect throughout Minnesota. They receive reports about animals that are lacking proper food, water, and shelter. They also participate in larger, more complex cases involving cruelty, with on-site investigations and seizures aiding law enforcement agencies that seek AHS assistance.

During the year ended June 30, 2020, our Humane Investigations unit received 1,698 requests for assistance and opened 685 formal cases. Follow-up investigation of these cases took AHS agents into 80 of Minnesota's 87 counties. Those investigations impacted the lives of 8,555 animals.

AHS took in 6,278 animals from 76 other animal welfare organizations throughout Minnesota and other states, finding homes for animals that would otherwise face euthanasia in overcrowded facilities.
